



Description: DUE TO AN INAPPROPRIATE MAINTENANCE PROCEDURE USED ON A WELDING MACHINE AT A RELAY SUPPLIER, WELDING OF COMPONENTS WITHIN THE RELAY MAY HAVE BEEN PERFORMED INCORRECTLY RESULTING IN IMPROPER ELECTRICAL CONDUCTION. AS A RESULT, ONE OF THE FOLLOWING CONDITIONS MAY OCCUR DEPENDING ON WHICH SYSTEM IS USING THE DEFECTIVE RELAY:-IF THE RELAY FOR THE ENGINE CONTROL UNIT FAILS, THE ENGINE WILL STALL WHILE DRIVING AND CANNOT BE RESTARTED.-IF THE RELAY FOR THE ENGINE VALVE LIFT CONTROL FAILS, THE ENGINE WARNING LAMP WILL ILLUMINATE AND FAIL-SAFE MODE WILL BE ACTIVATED, LIMITING AVAILABLE ENGINE POWER.-IF THE RELAY FOR THE RADIATOR FAN FAILS, THE ENGINE COOLANT TEMPERATURE WILL RISE, THE COOLANT TEMPERATURE WARNING LAMP WILL ILLUMINATE, AND THE ENGINE MAY OVERHEAT.

Accident Indicator

Damage Severity

Damage events result in one of the following severity levels:

- Moderate: Moderate damage may affect multiple components of the vehicle and may impair the vehicle's operation and/or safety.
- Severe: Severe damage usually affects multiple components of the vehicle and is likely to compromise the vehicle's operation and/or safety.

Failed Emissions Inspection

New Owner Reported

When a vehicle is sold to a new owner, the Title must be transferred to the new owner(s) at a Department of Motor Vehicles.

Ownership History

CARFAX defines an owner as an individual or business that possesses and uses a vehicle. Not all title transactions represent changes in ownership. To provide estimated number of owners, CARFAX proprietary technology analyzes all the events in a vehicle history. Estimated ownership is available for vehicles manufactured after 1991 and titled solely in the US including Puerto Rico.
